Terms and Conditions

1. The retainer shown above is refundable *for* two weeks from the date shown below.
2. Only the items listed in this agreement will be provided.
3. Duplicate photos produced at the photographer's expense may be used *for* promotional purposes and shown *to* prospective clients as examples of the photographer's work.
4. To avoid confusion on the wedding day, Mike Force and his assigns will be the exclusive providers of photography for this wedding. However, family and friends are welcome *to* take candid photographs at the reception.
5. The photographer's work is copyrighted material and may be reproduced or copied only by the photographer.
6. Any items listed in this agreement which remain un-ordered three (3) months following the wedding shall be forfeited and no refund will be made.
7. Mike Force Photography takes great care in the exposure, development and delivery of photographs. However, in the event that Mike Force Photography fails to comply with the terms of this agreement; liability is limited *to* a refund of payments.
8. Mike Force photography cannot be held responsible for lack of coverage resulting from weather conditions, or schedule complications caused by, but not limited *to*, anyone in or at the wedding or by the church/synagogue/hall restrictions.
9. No part of any order of photographs from this wedding will be delivered until the total balance of all orders is paid.
10. Payments will be made according *to* the above schedule or this agreement is cancelled.
11. In the event of a cancellation of this agreement, some part of the fee on this agreement may be refundable. I agree *to* the studio policy on cancellations and refunds.
12. All photographs requested during the planning session or requested at any other time will be purchased unless some element of the photo is objectionable.
13. Any image which has a minimum of one print ordered will be saved for at least one year, all others will be discarded.
14. The undersigned acknowledge that they have received and read the Mike Force Photography price list which is incorporated herein by reference.
15. The undersigned party(s) agree to pay all legal fees and costs that may be incurred in the collection of any or all of the unpaid balances owed to Mike Force Photography.
